Which pool of candidates do you belong to?

EU candidates

There are **30 (thirty) available seats** for EU citizens living anywhere and non-EU citizens living in Italy legally (with a “permesso di soggiorno”/residence permit), who will be ranked in the **EU Ranking**.

You should apply as a EU candidate if you fall under any of the following categories:

- You have a passport of one of the countries mentioned below* and you live anywhere around the world;
(eg. You have a Spanish passport and you live in the Philippines)
- You don't have a passport of any of the countries mentioned below* BUT you live in Italy and have a valid permesso di soggiorno/residence permit;
(eg. You have a Colombian passport and you live in Italy with a valid residence permit)
- You have more than one passport, for example a non-EU passport AND a EU passport and you live anywhere in the world.
The EU passport always takes priority as mentioned in the [Application Guidelines](#);
(eg. You have a Brazilian and a Portuguese passport, you live in Brazil).

NON-EU candidates

There are **50 (fifty) available seats** for non-EU citizens living abroad (that is students requiring a student visa): who will be ranked in the **NON-EU Ranking**.

You should apply as a NON-EU candidate if you fall under the following category:

- You don't have a passport of any of the countries mentioned below* and you live anywhere in the world (excluding Italy).
(eg. You have a UK passport and you live in the UK.)
(eg. You have a Korean passport and you live in Korea.)
(eg. You have a US passport and you live in France.)
(eg. You have an Indian passport and you live in the UAE.)

*** list of EU and EU-assimilated countries:**

EU countries: Austria, Belgium, Bulgaria, Croatia, Republic of Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden.

European Economic Area (EEA) countries: Iceland, Liechtenstein, Norway, Switzerland.

N.B. ALL UK passport holders (with no dual European nationality) MUST apply as **NON-EU candidates** for admission purposes.

What happens if you started or submitted an application for the wrong pool of candidates?

- If you realize you made a mistake before submitting the application, **please notify Cattolica International Recruitment office** (international.inquiry@unicatt.it).
- If you realize you made a mistake after submitting the application, **please notify Cattolica International Admissions office** (international.admissions-rm@unicatt.it)

The Cattolica International Admissions office will always check the documentation provided in your application. If necessary, they will reallocate you to the correct pool and you will be notified of the reallocation.
