



LAW COURSES TAUGHT IN ENGLISH

Are you a law student considering a study abroad or exchange period at [Università Cattolica del Sacro Cuore](#), in Milan?

Here are the courses and other activities that are taught in English. Some courses are offered either in the Fall or in the Spring semester, while others are one-year courses, meaning that they begin in the Fall semester and last until the end of the Spring semester (but don't worry: if you stay with us only for one semester, and want to attend part of a one-year course, you may discuss the matter with the professor and sit a partial exam, thereby earning fewer ECTS).

Upon agreement with the professor concerned, Incoming students may choose to attend only half of the chosen one-year course(s) and sit a partial exam, thereby earning fewer ECTS than those indicated in the table.

2. INTERNATIONAL CURRICULUM

Erasmus+ students are allowed to take only one course from the International Curriculum. Also, registration in selected course is required prior to arrival. Interested students are invited to follow instructions that will be send via email once the course registration process is open.

3. OTHER ACTIVITIES

Willem C. Vis Int'l Commercial Arbitration Moot

International students who plan to stay for the whole academic year may apply to become a member of the team representing Università Cattolica at the Vis Moot, an international competition on matters regarding the law of international commercial arbitration and the Vienna Convention on contracts for the international sale of goods.

5 ECTS (October > April)

Jessup International Law Moot Cour Competition

International students who plan to stay for the whole academic year may apply to become a member of the team representing Università Cattolica at the Jessup, an international moot court competition. Students will simulate a trial before the International Court of Justice and work on public international law matters.

5 ECTS (October > March)

PAX Moot

International students who plan to stay for the whole academic year may apply to become a member of the team representing Università Cattolica at the PAX Moot, an international competition on private international law matters.

4 ECTS (October > April)

Manfred Lachs Space Law Moot Court

International students who plan to stay for the whole academic year may apply to become a member of the team representing Università Cattolica at the Manfred Lachs, an international moot court competition. Students will simulate a trial before and work on space law matters.
